TRAINING GUIDE FOR NORTH SLOPE TRAVEL & WORK

ESCORTED PERSONNEL: Personnel who may travel to the Slope and remain in the main camp area for the entire duration of their stay. If personnel leave the main camp area, they must be escorted always by a person who is fully trained.

UNESCORTED PERSONNEL: Personnel who travel to the Slope and will be going outside the main camp area for the purpose of performing work. The course listing below are *minimum* requirements; additional training is necessary depending on the nature of the task being performed. Courses in bold italics are included in the NSTC Unescorted +H2S course; all other courses are site-specific and can be obtained by contacting your sponsor or local Safety Specialist.

- Effective 10/1/2016 for Kugaruk personnel using the ConocoPhillips radio system.
- Required for personnel based on North Slope. 11/28/2022: Combined CPA-REQ-300-ALP and CPA-300-KRU
- Effective 1/17/2018: North Slope based personnel except those with a higher EIP Worker, Individual Worker or Designated Worker level of training.
- Workers who issue, initiate, work under or oversee permitted work, and their supervisors. Update 10/29/2019: Alaska Safety Alliance,. Telephone: 907-770-5250. Website: <https://www.alaskasafetyalliance.org/>
- Effective 2/15/2019: Individuals required either physical or logical access to systems connected to Operations Technology (OT) systems. Includes personnel who will be doing work associated with our Process Control Systems (*Network, OT, BPCS, Metering, SIS, Fire and Gas*). For clarifications, contact NSOD Automation Engineering, 907-265-6446.
- Individuals working under Energy Isolation Procedures. Contractors = Annual Refresher, COPA = 3 year Refresher
- Required for Kugaruk Field; substitute for this requirement is NPR-A training
- Drivers requiring access to Alpine Runway
